# FSA Exam Restructuring for Fall 2025

The SOA announced a significant restructuring of the FSA exam tracks for the Fall 2025 sittings and onwards. There is still more detail to be released by the SOA as we get closer to the Fall 2025 timeframe. For now, we know that the ideas are to provide a flexible pathway to FSA (potentially allowing candidates to take exams in multiple FSA tracks), a regulatory material shift, improved syllabus and source materials, availability of exam feedback, and more frequent exams (for certain exams) and faster grading. # Exam Strategy with Upcoming Changes

At this point, there is still a lot of uncertainty around the details of the exam changes. We don't believe there are any huge differences that would result in a specific strategy regarding the timing and order of exams. We would simply advise current students to continue with the standard FSA pathway as it is provided now. Focusing your time on studying for the exam at hand will be much more valuable than trying to predict and plan for various scenarios in the future at this point.

#### Syllabus Change Timing

The syllabi for Exams DP and Risk Mitigation change during the winter and will be valid for Spring 2024 and Fall 2024 sessions. Exam VR typically changes during the summer, and the current syllabus is valid for Fall 2023 and Spring 2024.

# **SPRING 2024 SYLLABUS CHANGES**
